**INSIEL S.p.A.** is the person responsible for the processing of Personal Data (Article 28 of the GDPR) connected to the provision of the services it provides to the Bodies and Agencies of the autonomous Region of Friuli Venezia Giulia as part of the Regional Integrated Information System (S.I.I.R.) pursuant to the regional law of 14 July 2011, n. 9.

**Purpose of the processing:** the data are provided for the obligations required in the administrative procedure governed by the law and the implementing regulation and/or for the purposes relating to the contractual relationship, and are processed according to the provisions in force for the purposes of the procedure for which they were requested and are used exclusively for this purpose and for the institutional purposes of the Regional Agency for Rural Development - ERSA. In case of failure to provide the requested data, it is not possible to start the procedure if such data is essential for carrying out the investigation.

**Recipients of personal data:** the data may be communicated to other Public Administrations as well as to other subjects who request access to the documents of the related administrative proceedings, according to the methods and within the limits of the provisions of current legislation on the matter.

**Period of retention of personal data:** personal data will be kept for the time strictly necessary to achieve the purposes for which they were collected, without prejudice to the provisions regarding the duration of publications for the purposes of transparency and regarding archiving and conservation, also IT, documents.

**The interested party has the right,** within the limits set by Chapter III of the GDPR, to request access to their personal data, rectification, cancellation and limitation thereof, has the right to object to the processing and has the right to lodge a complaint with the Guarantor for the protection of personal data.

**The interested party is obliged** to provide the requested personal data. In the absence of the data necessary to verify the requirements for accreditation, ERSA will not be able to process the request.
